(Cayman Certificate)

For individuals and families who wish to reside in the Cayman Islands without being employed or conducting business.

Minimum Property Investment

**CI\$1,000,000**

in approved residential real estate



**PERMANENT RESIDENCE BY INVESTMENT**  
(Section 15(6))

For individuals and families who wish to obtain Permanent Residence in the Cayman Islands through a qualifying investment.

Minimum Property Investment

**CI\$2,000,000**

in approved residential real estate
